

**TOWNSHIP OF SHAMOKIN
NORTHUMBERLAND COUNTY, PENNSYLVANIA**

ORDINANCE NO. 2015 - 3

AN ORDINANCE OF THE TOWNSHIP OF SHAMOKIN, NORTHUMBERLAND COUNTY, PENNSYLVANIA, VACATING A PORTION OF TOWNSHIP ROAD #768, A/K/A ROSE ROAD, BEGINNING AT THE SOUTHERN BOUNDARY OF TAX PARCEL #044-00-044-007-M, AND CONTINUING IN A NORTHERLY DIRECTION TO ITS INTERSECTION WITH SHAMROCK ROAD, A/K/A STATE ROUTE 2010.

WHEREAS, Township Road #768 a/k/a Rose Road, is a public road located within the Township of Shamokin, Northumberland County, Pennsylvania; and

WHEREAS, the Supervisors of the Township of Shamokin have determined that a portion of Township Road No. 768 a/k/a Rose Road is not necessary for public convenience, and that continued maintenance of the same is burdensome and unnecessary; and

WHEREAS, Shamokin Township intends to vacate the northern end of Rose Road, beginning at the southern boundary of property now or formerly owned by Dennis L. Stonerod, tax parcel #044-00-044-007-M, to its intersection with Shamrock Road, a/k/a State Route 2010. A true and correct of a map depicting the portion of the road in question is attached hereto, made a part hereof and designated as Exhibit "A".

NOW, therefore be it ORDAINED and ENACTED by the Board of Supervisors of Shamokin Township, at regular meeting duly assembled, it is hereby ORDAINED and ENACTED by and with the authority of the same, that the portion of Township Road #768 a/k/a Rose Road, beginning at the southern boundary of tax parcel #044-00-044-007-M and continuing in a northerly direction to its intersection with Shamrock Road, a/k/a State Route 2010, as it appears on Exhibit "A", is hereby

vacated with respect to any interest therein of Shamokin Township as a roadway, street, alley, or other public highway.

The vacated portion of the public road shall be declared as a private road, of a width of twenty-five feet (25'), for the use and benefit of the owners of lands through or along which it passes, to be maintained and used as private roads are now maintained and used under existing laws. Shamokin Township shall have no further duty to maintain, repair, or responsibility whatsoever for that portion of Rose Road being vacated herein. Moreover, Shamokin Township shall have no responsibility for or involvement in any disputes among or between private landowners with regard to the vacated portion of Rose Road.

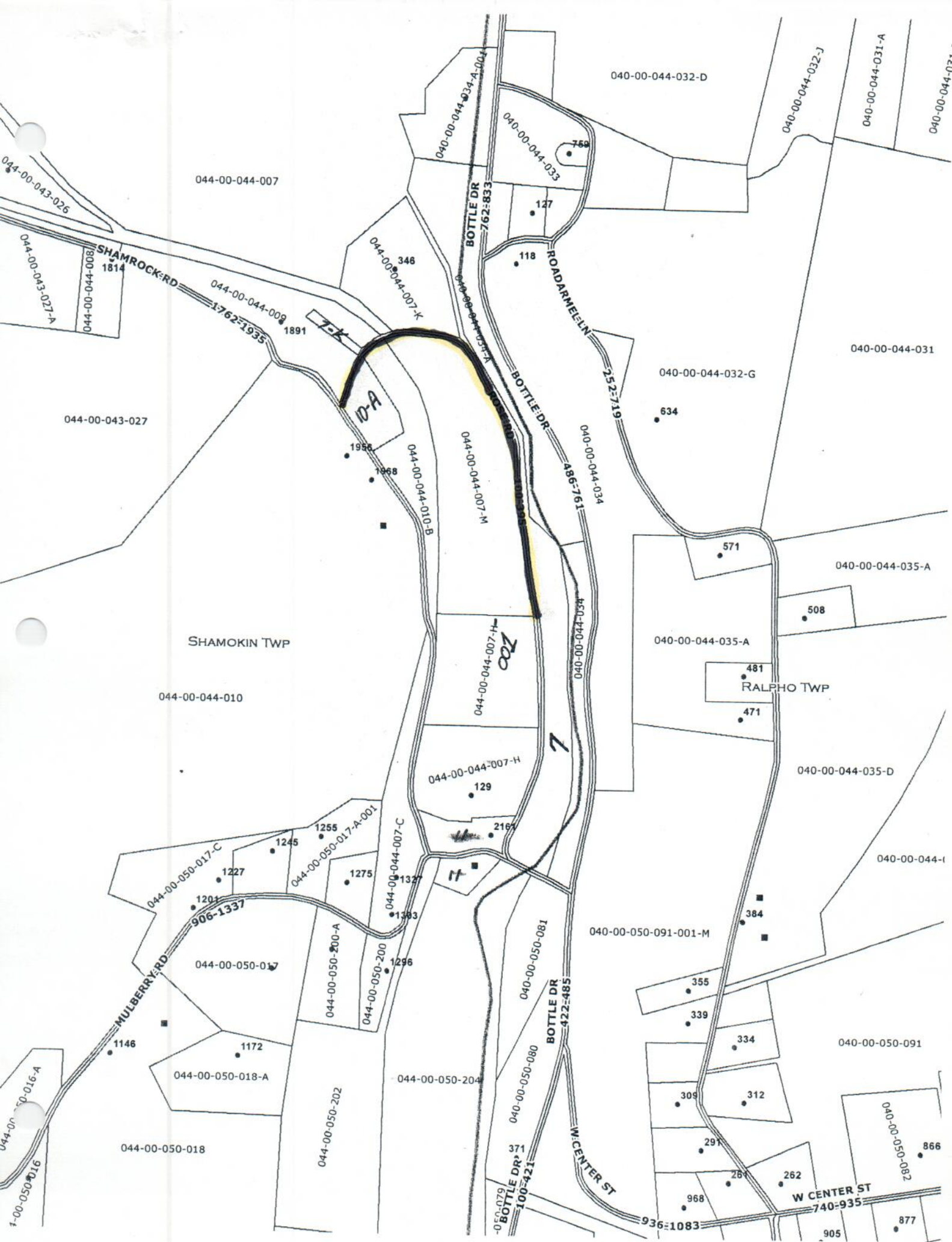
