ORDINANCE NO. 1999-1

AN ORDINANCE OF THE TOWNSHIP OF SHAMOKIN, NORTHUMBERLAND COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 1996-1, SECTION 6 AND ORDINANCE NO. 1990-1, SECTION 2.09 PROVIDING FOR THE PERMIT FEE FOR BUILDING PERMITS AND DRIVEWAY PERMITS.

BE IT ORDAINED AND ENACTED by the Supervisors of Shamokin Township in regular meeting duly assembled, it is hereby ORDAINED and ENACTED by and with the authority of the same as follows:

1. Amendment To Ordinance No. 1996-1, Section 6.

Ordinance No. 1996-1, being the Driveway Permit Ordinance of the Township of Shamokin is hereby amended to read as follows:

A. Section 6. Fees.

Application for a driveway permit shall be accompanied by a fee, payable to the municipality based upon the estimated cost of the proposed construction as determined by the Building Permit Officer at such rates as may, from time to time, be established by the Township Board of Supervisors by resolution. The rates adopted by the Township Board of Supervisors by resolution shall be applicable solely to driveway permits obtained by the property owner from the Building Permit Officer in the event that the said Driveway Permit has been obtained

prior to the commencement of construction.

Should application for a driveway permit be made by a property owner at any time subsequent to the commencement of construction, the applicable driveway permit fee shall be increased by the sum of Two Hundred (\$200.00) Dollars in excess of that otherwise prescribed.

- B. The remainder of Ordinance No. 1996-1 is hereby ratified in its entirety as though set forth herein.

2. Amendment To Ordinance No. 1990-1, Section 2.09.

Ordinance No. 1990-1, being the Building Permit Ordinance of the Township of Shamokin is hereby amended to read as follows:

A. Section 2.09. Fees.

Application for a building permit shall be accompanied by a fee, payable to the municipality based upon the estimated cost of the proposed construction as determined by the Building Permit Officer at such rates as may, from time to time, be established by the Township Board of Supervisors by resolution. The rates adopted by the Township Board of Supervisors by resolution shall be applicable solely to building permits obtained by the property owner from the Building Permit Officer in the event that the said Building Permit has been obtained prior to the commencement of construction.

Should application for a building permit be made by a property owner at any time subsequent to the commencement

of construction, the applicable building permit fee shall be increased by the sum of Two Hundred (\$200.00) Dollars in excess of that otherwise prescribed.

B. The remainder of Ordinance No. 1990-1 is hereby ratified in its entirety as though set forth herein.
