ORDINANCE NO. 2000-2

AN ORDINANCE OF THE TOWNSHIP OF SHAMOKIN, NORTHUMBERLAND COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 1986-1, BY REQUIRING THE OBTAINING OF A PERMIT BEFORE ANY WORK IS COMMENCED INCIDENT TO THE SURFACING OR RESURFACING OF A DRIVEWAY WITHIN THE TOWNSHIP OF SHAMOKIN, NORTHUMBERLAND COUNTY, PENNSYLVANIA

The Board of Supervisors of the Township of Shamokin, Northumberland County, Pennsylvania, do hereby establish and ordain, by this Ordinance hereby adopt and ordain as follows:

Section 1.

Section 3 of Ordinance 1986-1 is hereby amended to read as follows:

SECTION 3:

No person, owner and/or contractor shall hereafter install, construct, alter, reconstruct or initiate any work; or allow the installation, construction, alteration, reconstruction or initiation of any work in reference to the installation or surfacing or resurfacing of a driveway, without first obtaining a permit therefor from the Board. The application for a permit shall be in a form prescribed by the Township and submitted to the Township in triplicate. The application shall reflect and illustrate the location of the driveway relative to the premises and shall designate the course, grade, structure, materials and drainage facilities, if any, involved in the construction, alteration, reconstruction or surfacing or resurfacing of the driveway.

For purposes of this Ordinance, any person,

owner and/or contractor who shall surface or resurface an existing driveway within the Township shall be responsible for the submission of an application setting forth the information required above. All permits issued for installation, construction, reconstruction, surfacing or resurfacing of a driveway shall have printed thereon the requirement that any change or alteration, including surfacing or resurfacing, to be done upon the driveway in the future, shall require the submission of an application for a permit, setting forth the information herein required.

Section 2.

The remainder of Ordinance 1986-1, as amended, is hereby ratified and re-adopted in its entirety as though set forth herein.
