The regular monthly meeting of the Shamokin Township Supervisors was held on January 2, 2024 at 7:30 p.m. at the Shamokin Township Municipal Building.

In attendance were Chairman Greg Rachau, Vice-Chairman John Klinger, and Supervisor Paul Rapp, Solicitor Jim Bathgate, Roadmaster Jon Clemens; Secretary/Treasurer Stephanie McKinney and 2 visitors.

Supervisor Rachau moved, seconded by Supervisor Rapp to approve the December minutes as presented. Motion was passed unanimously.

The Treasurer's Report was read and approved on a motion by Supervisor Klinger seconded by Supervisor Rapp. Motion was passed unanimously.

Solicitor's Report

Solicitor Bathgate reviewed a building permit report from Light-Heigel and he will inform them about placing an extra box on the report for final inspections.

Building Addition

Jon Clemens reported that the exterior doors are coming Thursday and a bid document needs to be done for the HVAC.

Apple Blossom Lane

KPI sent a letter to the residents concerning their multi-use driveway that is continuously washing out onto Chestnut Road. The board decided that KPI and the Roadmaster will meet with the residents on this road. The residents must come up with a plan to repair their private road.

Fire Dept.

Supervisor Rachau moved, seconded by Supervisor Klinger to give \$4,000 worth of fuel to the fire company in 2024. Motion was passed unanimously.

The Northumberland County Planning Commission granted a stormwater exemption for David & Kristine Rinderle.

PSATS Dues

Supervisor Rachau moved, seconded by Supervisor Rapp to approve the dues for PSATS except for the News Laws Service with the invoice totaling \$1,012. Motion was passed unanimously.

Adams Park Road

Mr. Yucha addressed the funds for Adam Park Road asking if the residents must keep paying the quarterly fees. The board responded that there is \$10,350 in the fund and if a pump goes bad it would deplete all the funds and an electric bill is paid for from the fund every month. So the residents will still need to build up the fund for future issues. There were two residents that have not paid their invoices in over a year. Supervisor Rachau moved, seconded by Supervisor Klinger to send a letter to the Barbara Munson and Donald and Christine Munson for past due invoices for Adams Park Road sewage system. Motion was passed unanimously.

Supervisor Rachau moved, seconded by Supervisor Rapp to adjourn the meeting at 8:23 p.m. and to pay the bills. Motion was passed unanimously.
